We believe that children work very hard throughout the school year, so when summer comes, they deserve some FUN! That's why Kiddie Junction Educational Institute sponsors **For Kids Only** for children ages 5-12 (must be entering Kindergarten in the Fall and fully potty trained).

For Kids Only is a supervised day camp right in your neighborhood. With fun outdoor and indoor activities designed for all age groups, there is always plenty of excitement for everyone.

## Swimming

For Kids Only will have use of all Des Plaines park district pools. **Pool passes can only be used Monday-Friday during camp hours.**

## Field Trips

Field trips are taken weekly. Our camp calendar has specific dates and destinations.

## Weekly Themes

Our weekly themes keep everyone looking forward to what's to come. No week is the same and there is something for everyone! Our camp calendar outlines each weekly theme and special activities for each day of the week.

**Camp is located in the gym at St. Stephen's Church in Des Plaines  
at 1835 Spruce Avenue.**

**Please use the parking lot entrance off Spruce Avenue.  
We will be located in the gym area (entrance is at Door 1)**

## Drop Off and Pick Up

Campers arriving before 6:45am are to be dropped off at Kiddie Junction at 1619 E. Oakton St., Des Plaines. Campers arriving between 7:00am-9:00am are to be dropped off at St. Stephen's. **No campers will be admitted after 9:00am\*.**

*\*Field trip days may require an earlier drop off time.*

**When dropping off your child, please call Ms. Danielle at 224-220-6732.**

**When picking up your child, please call Ms. Meghan at 708-732-5172.**

All campers will be picked up from Saint Stephen's Church. When we are out at the pool or a field trip, we will return at 3:00pm. **Please call 5 minutes prior to your arrival to pick up your child.** This allows time for your child to clean up and gather their belongings. When you arrive to pick up, a counselor will greet you at Door 1 with your child. **All campers must be picked up by 5:30pm\*.**

*\*A late fee will be applied for any pick ups after 5:30pm. The first occurrence will result in a fee of \$1 per minute per child. Any further occurrences will result in an automatic \$15 charge per child plus an additional \$1 per minute per child.*

# For Kids Only Day Camp Contract and Consent Form

## Enrollment/Application

This application and deposit constitute an enrollment agreement only when accepted by For Kids Only Day Camp in writing and shall be construed and enforced in accordance with the laws of the State of Illinois. For Kids Only considers enrollment and/or payment as acknowledgement and acceptance of all the terms of this agreement by Parents and Camper. For Kids Only Day Camp reserves the right to accept or reject applicants.

Parents hereby state that Camper is of sufficient maturity to properly care for his/her hygiene and participate in the Camp's program. Completing this application implies that Parents and Camper understand that For Kids Only Day Camp has the right to dismiss any camper whose behavior, attitude, or action is, in our judgement, contrary to the best interest of our Camp community.

This includes, but is not limited to: pranks causing bodily harm, embarrassment, or destruction of property, excessive fighting or other aggressive behavior, harassment, bullying, sexual behavior, theft, excessive disobedience, or for other conduct that is ruining another Camper's experience or is harmful to the Camp.

It is understood that For Kids Only Day Camp has the right to dismiss any Camper whose Parent shows unreasonable, irrational, or unsuitable behavior that is in our judgement contrary to the best interests of our Camp community. It is understood and agreed, by Camper and Parents, that our possession or use of tobacco, alcohol, or controlled substances while enrolled in camp will bring immediate dismissal.

Possession of any weapon may also bring immediate dismissal. For Kids Only Day Camp will, if necessary, search for, confiscate, and dispose of any items that violate Camp policy or are used in inappropriate ways.

## Payment Contract

Parents understand that Camp fees are due in full prior to the beginning of the week. **A \$35 late fee will be assessed for any payment received after Friday prior to the week of attendance** and \$5 added each day after. Parents further understand that unused days are non-refundable and non-transferable. Parents understand that registration fees are non-refundable. Tuition Express is an automatic payment program that is also available for our camp families, so you avoid any late fees.

## Activities- Consent and Release

Parents and Camper acknowledge that a wide variety of activities are conducted at For Kids Only Day Camp and Parents hereby give permission for Camper to participate in these activities, assuming all ordinary risks normally inherent to the nature of the activities. Such activities include, but are not limited to, the following: swimming, group sports, games, and scheduled field trips. Camper agrees to abide by all rules set by For Kids Only Day Camp regarding all activities including, but not limited to, rules relating to personal behavior and safety. Camper desires and consents to take part in all such activities. Camper assumes all the ordinary risks normally inherent to the nature of the activities and events to be conducted and agrees that neither For Kids Only Day Camp nor any of its directors, officers, employees, agents, or other persons conducting such activities shall be responsible for any damages or injuries resulting to Camper in the absence of gross negligence.

### **Transportation Consent**

By enrolling in For Kids Only, Parents hereby authorize the transportation of Camper to and from all field trips, activities, and locations that For Kids Only Day Camp deems reasonable each day.

### **Photographic Consent**

By enrolling Camper in For Kids Only Day Camp, Parents hereby give permission to For Kids Only Day Camp to photograph Camper in a reasonable and professional manner for promotional and advertising purposes (i.e. camp videos, online social media such as Facebook.com and YouTube.com, scrapbooks, brochures, picture day, etc.)

### **Emergency Medical Consent**

By enrolling in For Kids Only Day Camp, Parents hereby authorize the procurement of whatever emergency medical treatment may be necessary for Camper. Parents also authorize the removal of Camper from Camp premises for the purpose of obtaining such emergency medical treatment if the need arises. Parents agree to hold For Kids Only Day Camp harmless for the nature, performance, and outcome of any such emergency medical treatment and that the determination of whether an emergency has risen shall be left to the sole discretion of For Kids Only Day Camp.

### **Medical Fees**

By enrolling Camper in For Kids Only Day Camp, Parents hereby agree to be fully and solely responsible for all fees and costs arising from any medical conditions or treatments for Camper's participation in For Kids Only Day Camp, including, but not limited to, the administration of emergency medical care.

### **Personal Property**

For Kids Only Day Camp assumes no liability for loss or damage to Camper's personal property or for injury incurred as a result of use of personal property. For Kids Only Day Camp discourages all borrowing and lending among Campers or anyone working in Camp. The Camp also assumes no responsibility for money or valuables brought to Camp by Campers. Campers will be held responsible for damage to property and equipment of For Kids Only Day Camp caused by Camper's negligence and will be charged accordingly for repairs or replacement. **Cell Phones, Electronic Devices, and Toys are not allowed to be brought to camp.**

### **Release**

For Kids Only Day Camp will not release your child(ren) to any individual (including a parent) who appears to be intoxicated or impaired by any stimulant. The local police will be contacted for assistance if necessary.

### **Potty Trained**

All campers must be fully potty trained.



# For Kids Only Summer Camp Rules and Expectations

Parents, please review this with your child before the first day of camp.

At camp, we want every child to feel safe, have fun, and enjoy new experiences. To help make that happen, we have a set of rules and expectations that all campers are expected to follow. These rules support a positive and respectful environment for everyone.

## Camper Rules

All campers must:

- Be kind and respectful to others – this includes other campers, staff, and themselves.
- Listen and follow directions the first time they are given.
- Keep hands, feet, and belongings to themselves.
- Use appropriate language – no teasing, name-calling, or inappropriate words.
- Stay with their group and ask permission before leaving any activity area.
- Respect the camp's materials, equipment, and spaces.
- Try their best, participate in activities, and have a positive attitude!

## Bus Rules

In addition to the camp rules outlined above:

- Campers must remain seated and buckled (if applicable) while the bus is moving.
- Voices should be kept at a quiet level.
- No eating or drinking on the bus.
- All body parts must remain inside the bus at all times.
- Follow directions from bus drivers and staff without delay.

## Pool Rules

In addition to the camp rules outlined above:

- Adhere to the guidelines outlined in the For Kids Only Pool Rules (attached).
- Follow all posted pool rules at the facility and lifeguard/staff instructions.

## Field Trip Expectations

In addition to the camp rules outlined above:

- Campers must stay with their assigned group at all times.
  - Listen carefully to instructions before, during, and after the trip.
  - Practice good behavior and manners when visiting public places.

## **Behavior Policy**

We understand that all children are learning, and we use redirection and guidance throughout the day. However, consistent failure to adhere to the outlined camp, pool, bus, or field trip expectations will be addressed using the following steps:

- 1. First Occurrence – Verbal Warning:** The camper is reminded of the rule and given a chance to correct the behavior.
- 2. Second Occurrence – Phone Call Home:** Parents/guardians will be contacted to discuss the concern.
- 3. Third Occurrence – Consequence:** The camper will miss the weekly field trip.

**Continued violations may result in removal from the program.**

**In cases involving unsafe or aggressive behavior, property damage, or serious rule violations, immediate dismissal may occur without prior warnings.**

## **What to Bring & What to Leave at Home**

### **Bring daily:**

- A lunch (except for cookout days)
- A refillable water bottle
- A towel
- Wear For Kids Only camp shirt every day
- Wear closed-toed shoes
- Wear bathing suit under camp clothes
- Sunscreen and bug spray (to be left at camp)

### **Please leave at home:**

- Toys, trading cards, electronics, or anything valuable
- Any items that could be considered unsafe

## **Your Support Is Important**

We ask that families review these rules and expectations with their camper before camp begins. When home and camp work together, children are more likely to succeed and enjoy their summer experience.

# For Kids Only Pool Rules

## I. General Safety & Behavior

- **Listen to Lifeguards and Counselors:** Always obey the instructions of the lifeguards and counselors immediately. They are here to keep you safe!
- **Walk, Don't Run:** No running in any area of the pool.
- **Never go into the pool alone.** Counselors are the first ones in the pool and last ones out of the pool.
- **Enter Feet First (Unless Directed):** Always enter the pool feet first, unless you are in a designated deep end and a lifeguard has given permission for diving or jumping.
- **No Pushing or Shoving:** Keep your hands to yourself and never push anyone into the pool or in the pool area.
- **No Horseplay:** Roughhousing, dunking, or overly aggressive play is not allowed.
- **Respect Others:** Be mindful of other swimmers and give them space.
- **Report Problems:** If you see something unsafe or someone is not following the rules, tell a counselor or lifeguard right away.

## II. In the Pool

- **Swim in Designated Areas:** Stay in the areas of the pool appropriate for your swimming ability as indicated by your counselor.
- **No Gum or Food in the Pool:** Keep all food, drinks, and gum out of the pool and off the immediate pool deck.
- **No Toys:** Toys are not permitted at the pool.
- **Diving/Jumping:** Only dive in designated deep ends where a counselor and lifeguard are present and have given you permission.
  - No running dives.
  - Ensure the area is clear before diving or jumping.
  - No flipping or dangerous acrobatics off the side of the pool.
- **Slide Rules:** You may only use slides if your counselor has indicated you are allowed to do so.
  - Go down the slide feet first, one person at a time.
  - Wait for the person before you to clear the landing area.
  - Exit the slide area quickly.

## III. Pool Area Etiquette

- **Keep Area Clean:** Help keep the pool area tidy by throwing away your trash.
- **Personal Items:** Keep your personal belongings in designated areas.
- **Always Stay with Your Counselor:** Remain with your group and counselor at all times. If you need to use the restroom, you must be accompanied by a counselor.

1st Occurrence: Verbal Warning

2nd Occurrence: Phone Call Home

3rd Occurrence: Miss the weekly field trip

Any further violation of camp rules may result in dismissal from the program.
